## Matters arising - Completed

**President Update** – Provided a verbal update on his work and the upcoming visit to Ukraine both he and the Head of Office will be making at the beginning of October along with his reflections of his attendance at various meetings he has had in Brussels with leading legislators

**Treasurer – Update** MM provided a documented update on the challenges he is currently experiencing in relating to the accounting software which he advises is not compatible with Luxembourg accounting process (All Excom members present acknowledged safe receipt of this update.

**Internal Auditor HB** – Provided his view that without the 2024 documents being made available to him he is unable to complete an internal audit 2024 and the importance of this process being carried out.

**Head of Office ND** provided the further commentary in reminding the Excom that EuroCOP Statutes are clear as described in 6.3.1 and the audit should not only focus on the financial aspect but also the organisation compliance of its function

Updated on the EuroCOP Affiliates from Finland Sweden Ireland Spain and Cyprus coming together in Brussels to meet with 10 MEPs and Civil Servants at the beginning of September.

EuroCOP were invited to the largest political group within the EU Parliament the EPP to attend and participate in their High Level Police Summit. updated and reminded the Excom of the interventions through the EU consultation process

An update was provided in relation to potential long professional development sponsorship with Axon Enterprises, Stark Events having undertaken having undertaken preliminary contract discussions with Axon and provided the Excom with their advice

(<u>Update post meeting</u>) The Excom agreed to sign off on a 3 year agreement and provided authority to the Head of Office to sign off behalf of EuroCOP
